DROP-OFF OF ARTWORK

All artwork will need to be delivered to the Upstate Visual Arts office and gallery. Drop off times are:

Friday, September 12th 1:00 - 7:00pm

Saturday, September 13th 11:00am - 4:00pm

Please have tag on works, the entry form, juror's card and check/s in an envelope.

Work must be hand delivered by artist, or by a designee with written permission from the submitting artist.

NOTIFICATION

Artists will be notified via email of jury selections.

Judging will take place on Sunday, September 14th.

PICKUP

WORKS NOT accepted in the show:

Pickup at the UVA office by Tuesday, September 16th.

WORKS IN THE SHOW:

Sunday, September 21st 5:00-6:00 pm at Fluor Field's show location.

There will be \$25/piece handling charge on works NOT picked up at these times, and a \$1/piece/day storage fee.

Works NOT picked up by Friday, September 26th will become the property of Upstate Visual Arts.

JURIED SHOW ELIGIBILITY

Artists may submit one original visual art works for judging in the following categories:

2D: painting, printmaking, drawing, etc.

3D: ceramics, fiber, glass, jewelry, relief, sculpture, wood, etc.

Photo/Digital: photography, digital, computer, etc.

Works will be selected from entries for the Juried Show only. All entries MUST be for sale.

Must be original work produced and signed by the submitting artist. Work must have been completed within the past three years, and not previously shown in a UVA Juried Show.

No works produced with commercial kits, molds, patterns, plans, pre-fabricated forms, or other commercial methods will be accepted.

No works created under the supervision of an instructor will be accepted.

No reproductions of works will be accepted. This does not apply to photography, digital, computer, or printmaking mediums.

HANGABLE WORKS

Works must be appropriately framed for the medium and securely wired for hanging. No clip mountings, or saw tooth hangers.

Gallery-wrapped canvas are acceptable with no staples visible, and sides painted.

Stained glass, hangable sculpture, or fiber works must be under 12 lbs. and able to be safely hung on a panel.

Maximum height including frame: 60"

Maximum width of any work including frame: 42"

Entry labels are to be filled out completely and securely attached to the upper right hand corner of the back of 2D works.

FREESTANDING WORKS

Pedestals will be provided for display.

Works can not exceed 40 pounds, require special handling or installation.

Jewelry makers must provide a means to safely display their work on a pedestal or for hanging.

UVA has the right to reject any submission of any art work or any artist at any show or juried exhibition. The decision of the UVA advisory committee is final.

LIABILITY: UVA takes great care of all submitted works, but does not assume responsibility for insuring the works. The receipt of an entry in the Juried show constitutes agreement by the artist with all conditions set forth in this prospectus.

PLEIN AIR COMPETITION & SILENT AUCTION \$500 GRAND PRIZE

Open to ALL artists. \$20 non-refundable entrance fee if postmarked by September 12th; Day of Event registration is \$30 (see details below)
SATURDAY SEPTEMBER 20th

- Pre-registered artists need to report to the Plein Air tent by 9:30am. Day-of registration (\$30) will begin at 9:30 and continue until 10:30 am, after which no further registrations will be accepted. Artists need to bring the surface(s) they are working on and have them marked with the official UVA stamp to prove the work was created on that day.
- Artists may set up anywhere inside or within a two-mile radius of the ball park except on the field. Due to restrictions put in place to protect the grass, no one will be allowed directly on the ball field, though artists may set up on the surrounding concourses.
- 10:00am - 5:30pm All works must be completed within this time to be eligible for the Grand Prize or selected for the Silent Auction.
- 5:45pm Works must be turned in to the UVA Tent
- 6:30pm Grand Prize winner and works for Silent Auction announced.

SUNDAY SEPTEMBER 21st

11:00AM - 4:30PM Silent Auction

All works selected for silent auction will have a \$100 minimum bid unless specified as higher by the artist. Artists have the right to decline to have their work submitted into the silent auction. UVA will retain a 30% commission on works sold. Works not sold remain the property of the Artists, and must be picked up after the close of the Auction and before 6 pm that day. Works not picked up at this time are subject to a handling and storage charge, and become the property of the UVA after September 26th.

GUIDELINES

- Works may be in any 2D media except Photography.
- Artists must provide their own materials and equipment.
- At their work area artists may display their portfolio and hand out business cards but may NOT display or have other works for sale.
- Artists are responsible for cleaning up their work area.
- UVA reserves the right to reject any artist who does not adhere to the guidelines of the competition.
